NOTES AND DOCUMENTATION CHECKLIST

UK National Private Pilot Licences are issued by the Civil Aviation Authority in accordance with the provisions of the Air Navigation Order, for the time being in force. All applicants are strongly advised to read NPPL/SLMG/SYL/REV 02, which describes in detail the requirements for the grant of a UK National Private Pilot Licence (SLMG) and any relevant Aeronautical Information Circulars before completing this form.

PLEASE DO NOT ENCLOSE ANY ORIGINALS APART FROM THOSE STATED – PHOTOCOPIES ARE ACCEPTABLE

1. Sections 1 to 3 and Section 9 and 10 of this form must be completed by all applicants personally.
2. Sections 4 to 8 should be completed by the Examiner(s) where appropriate and if applicable.
3. **PLEASE NOTE SECTION 8 MUST BE COMPLETED AND SIGNED – IF THIS IS LEFT BLANK IT WILL BE RETURNED.**
4. The Navigation and Skill Test(s) are in addition to minimum 32 hour course of flying training.

To apply for the grant of a UK NPPL (SLMG) you should enclose *photocopies* (unless otherwise stated) of the following documentation:

- a) RT Licence: **If applying for a RT Licence at the same time** pls enclose form FCL 508 'Application for the grant of a Flight Radio Telephony Operator's Licence' and we will forward this to the CAA. If you already hold a RT licence, we **DO NOT** need a copy.
- b) Medical Declaration: **ORIGINAL** valid UK NPPL Medical Declaration – **completed by your GP and NOT yourself** or copy of JAR Medical form confirming validity. (Validity must be sufficient to cover the anticipated licence Issue date).
Ensure you keep a copy for your files or enclose a sae for return of your original medical form
- c) Evidence of Identity. Passport or Birth Certificate only. **Photocopies are acceptable provided all relevant information is clearly presented.**
- d) Logbook: Photocopies of flying logbook pages showing NST, GST, latest logbook entries showing Examiners name and CAA ref and any completion of training/difference training. The logbook must be certified as correct at the last appropriate entry by the Chief Flying Instructor or Head of Training of the Registered Facility responsible for the course of training.
- e) Copy of Skill Tests (*if applicable*): Navigation Skill Test should be taken after all theoretical exams and must be taken before the General Skill Test. General Skill Test must be taken after all theoretical exams and appropriate training has been completed.
- f) Copy of licence (if applicable)
- g) Copy of Current Certificate of Revalidation (if applicable)
- h) Solo Cross-country Certificate (if applicable) – must be completed **after** the NST and **before** the GST

For holders of licences issued by an **ICAO Contracting State** claiming credit towards the issue of a NPPL, the NST may be waived if the holder has flown a total of 100 hours as pilot of aeroplanes and also flown a minimum of 5 hours PIC cross-country flight time in UK airspace in the 12 months prior to the date of licence application. Certified log book evidence required.

For applicants seeking credits based on existing qualifications and flying experience (e.g gliding certificates), reference should be made to cross-crediting document NPPL/XC/REV08, and enclose photocopies of relevant proof with this application.

Failure to submit all of the required documentation will lead to a delay in the processing of your application.
